

HI-FLO-SL SELF LEVELING GROUT

Technical Data Sheet

General:

Self leveling floor system designed to level floors as an underlayment to place tiles or other finishes that can be stained or sealed to use as a finish surface. Use over concrete or properly prepared wood systems from 1/8 to 2 inches. Prepare the substrate and use the system's polymer bonding adhesive prior to installation. Product eliminates high and low spots to provide a seamless leveled floor on interior areas.

Surface preparation:

Proper floor preparation is key to a successful application. Concrete floors must be at least 28 days old. All smooth areas such as hard trowel finishes must be roughened to provide some mechanical bond. Pressure clean area and use acid etching or cleaner suitable to open pores, remove all laitance, contamination, oil and dirt. If using acid, neutralize areas after with a solution of one tablespoon baking soda per gallon of water, wash off solution with garden hose or vacuum all areas and allow to air dry, then apply the bonding agent.

Mixing:

Stir well and apply a thin coat of bonding agent (undiluted) and let dry. Mix each Pail/ Bag by placing 5 quarts of cool potable mix water in a clean bucket then slowly add the powder while mixing with a drill mixer or suitable equipment to a lump free mix. Place by pump or if by hand, let mixture stand for 1-2 minutes to let it bleed all entrained air in the pot before placing.

Installation:

Using a pre-set height squeegee, pour mate-

rial over bonded surfaces and screed to the desired height. Work in a continued pattern; mixing, pouring and finishing. Product will seek its own level in + or -5 minutes after it is poured and consolidated.

It may be necessary to lightly finish and correct entrapped air bubbles that may appear. Wear spike shoes to work finish. Allow surface to slightly set to apply light trowel or broom finish.

Product Limitations:

Over wood floors that can deflect causing the underlayment to exceed its flexural limits. When installing don't allow cold joints greater than 5 minutes. Do not install on a hot floor in direct sunlight or in freezethaw conditions. Also, do not install thicker than 2" or exceeding mix water. After installation protect and **cure** work by water fog, blankets or chemical curing agent for 24 hours.

Package Coverage:

Each 50# unit will yield .45 Cu/Ft Use approved EVA type bonding agent.
